1. That the Akansha Educational Trust is a registered Trust under the Government of Sikkim vide registration No.72/DCE Vol.No .1 dated 28.03.2013.
2. That the Rungdung, Rhenock, Greenwood Academy under the Government of Sikkim Registration vide registration No. 366/S/E/02/03/2016 is of Non- Proprietary Character.
3. That the school is being is run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the institution is being and will be delivered to any individual in the Trust/Society/Company /School Management Committee or to any other person/entity. The saving , if any, after meeting the recurring and non- recurring expenditure and contributions to developmental , depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. The school is not paying charges towards using name, motto, logo or any other non-academic activities to any other institution , organization, or body.

6. The school will not open classes under CBSE pattern particularly classes IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and correspondent /manager of the school have individually gone through the provisions contained in the affiliations & Examination bylaws and circulars issued by the Board time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure that compliance of all statutory requirements like EPF, ESI and Labour Laws etc with respect to the school and staff of the school.
9. The school will ensure that the Building Safety, Water Safety, Health and Hygiene Certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed terms.
10. The school will ensure that all required infrastructure is available with the before starting classes.
11. The school will ensure that sufficient number of qualified teachers as per the provisions contained in the affiliation by-laws are available with the school before starting classes.
12. That the school will follow the provisions related to fee contained in the affiliations by-laws and will disclose the details of the fee to the students / parents every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce students/ parent to buy books/ stationary uniform from any particular shop.
14. The school shall strive to make efforts for conservation of environment.
15. That the school will ensure that the school fulfills all essential requirements before applying for affiliation and will fulfill all other conditions post affiliation and comply all the general rules as given in the affiliation or notified from time to time.
